THIS WARRANTY INCLUDES THE FOLLOWING:

A SURFACE OR ADHESION FAILURE CAUSED BY A DEFECT IN THE PRODUCT OR WORKMANSHIP

Commercial Bath Refinishing must be notified of such a defect immediately. Buyer must also produce paid invoice for the product in question. Commercial Bath Refinishing will inspect the problem area either on location or by client sent photos and determine whether the resulting damage was caused by a defect in the product or workmanship. If Buyer notifies Seller within the warranty period of any aforesaid defects in the materials and Buyer shows the materials were used and maintained in accordance with Seller's recommendations and standard industry practice, Seller will cure defects by suitable repair or replacement at its own expense and the original warranty period will remain in force.

THIS WARRANTY EXPRESSLY EXCLUDES THE FOLLOWING:

Excluding (but not limited to): Improper care or maintenance of the refinished surface as outlined in Commercial Bath's 'Care and Maintenance' sheet. Chipping, scratches, stains, or knife marks due to misuse or neglect of the refinished surface, abrasive damage or discoloration due to bleaches, dyes or acids, and/or problems caused by leaky plumbing. Peeling that is larger than one square foot. Any area larger than this causes water to lift the coating which can cause excessive peeling which may need to be stripped. Damage caused by sharp or heavy objects and bathmats with suction cups may cause damage to the surface. The use of harsh agents such as Comet, Ajax, or bleach may discolor or damage the surface. Areas of the surface may become more worn from heavy cleaning and/or heavy use. Damage to the surface resulting from heavy cleaning, excessive use, and/or leaky plumbing is expressly excluded under this warranty. Commercial Bath does not warranty Kitchen sink refinishing, Refinished tile floors and shower floors, Refinished grout, Refinished terrazzo shower pans, Rust or Rust repairs of any kind. All Caulking should be maintained regularly by the homeowner or property manager. Commercial Bath does not warranty fixtures that have been used for pet washing, for dying hair, use of bath bombs/salts or caulking, even when the caulking has been refinished. Commercial Bath is not liable for damage caused to painted walls, wallpaper, or any other surface from the removal of tape used to cover or mask the surrounding area.

OTHER WARRANTIES EXCLUDED AND NO OTHER WARRANTIES MADE:

This warranty is exclusive of any implied warranty of merchantability, fitness for a particular purpose, or other warranty of quality, whether expressed or implied, except for the warranty of title and against patent infringement. Seller's employees' oral statement does not constitute warranties, shall not be relied upon by Buyer, and are not part of this agreement. There are no warranties which extend beyond the description of the face hereof. Cure of the defects, in the manner and for the period of time provided above, shall constitute the Buyer's sole and exclusive remedy with respect to the product. Warranty is for the original Owner/Buyer and is only transferable when the original Owner/Buyer notifies Commercial Bath Refinishing in writing to transfer the job under the new Owner's name.
